In continuation of University Notification No. Au/Acad/U-09/2026/443-99 dated 13.04.2026 read with No. AU/Acad./U-09/2026/5650-59 dated 19.06.2026 and subsequent notices issued from time to time regarding admission to the B.Tech. (AI in Agriculture) Degree Programme for the Academic Session 2026-27, it is hereby notified for information of all concerned that the candidates who have confirmed/booked their provisionally allotted seats during the provisional seat allotment rounds 18th & onwards by depositing the prescribed non-refundable Seat Booking Fee of Rs.11,000/- (Rupees Eleven Thousand only), shall report, in-person, in Academic Section of Registrar's Office, SKUAST-K, Shalimar on **01.09.2026 (Tuesday) at 10.00 AM** for verification of original documents/testimonials and completion of admission formalities.

Eligible candidates shall produce, in original, along with one set of self-attested photocopies, the following documents/testimonials before the Board:

1. Domicile Certificate;
2. Marks Certificate(s)/Detailed Marks Card(s) of the qualifying examination;
3. Matriculation/Date of Birth Certificate;
4. Reserved Category Certificate, wherever applicable;
5. JEE(Mains)-2026 Score Card;
6. Printed copy of the online application form;
7. Printed copy of the Provisional Seat Allotment Letter generated through the University Admission Portal;
8. Four (04) recent passport size photographs; and
9. Any other relevant document(s)/testimonial(s).

The Counselling Board shall verify the eligibility, merit, reservation claim and all supporting documents/testimonials of the candidate before confirmation of admission. The Counselling Board may reject the candidate or recommend cancellation of the provisional allotment if the candidate:

- a. fails to report, in person, before the Counselling Board at the notified place, date and time;
- b. fails to produce the requisite original documents/testimonials;
- c. is found ineligible for admission;
- d. has submitted false, fabricated or invalid documents;
- e. has suppressed or concealed any material information; or
- f. is otherwise found ineligible under the applicable Statutes, Regulations, Notifications, Orders or the Admission Procedure.

The candidates shall also be required to deposit the balance fee of programme on 01.09.2026 after document verification & confirmation of the seat, through online mode of payment only. The link for such payment of balance fee shall be made accessible to the candidates through the portal/student dashboard, only. Upon completion of admission formalities, the candidates shall be issued a Provisional Admission Communiqué for reporting to the concerned Faculty/College.

Admission shall be deemed to have been confirmed only upon successful completion of Document Verification-cum-Counselling, payment of the prescribed fee(s), and fulfilment of all conditions prescribed by the University.

The concerned candidates shall be required to upload, as a pre-requisite to verification, certificates/documents as indicated above from Sr.No. 1 to 5, through SKUAST-K admission portal <https://skuastkashmir.in/IUMS/applicant/>, for which the access has been provided through their respective dashboards up to 01.09.2026 (10.00AM).

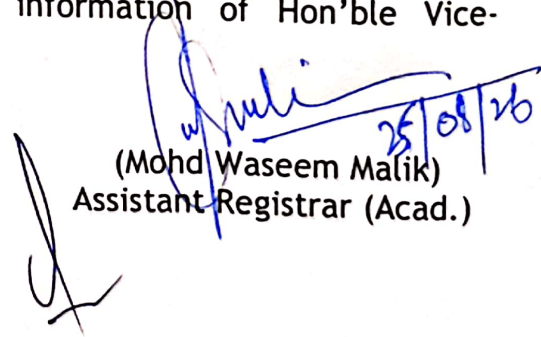
